

WMA Certified Mediator Renewal

According to WMA's records, it has been at least two years since you were either initially WMA certified or submitted MCEME documentation. If you would like to maintain your WMA certified status, please complete this renewal application form and enclose it along with your \$100 (\$75 annual membership dues plus \$25 application fee) payment to WMA. Continuing education and mediation experience must have occurred during the two year period following your last certification date in order to be counted toward your renewal.

Requirements:

1. Completed and signed application form
2. \$100 fee (\$25 application fee plus \$75 annual membership dues if not already current)
3. At least 20 hours of continuing education within the two-year renewal cycle, including a minimum of 10 hours in courses certified/qualified by a professional or educational organization. Please refer to the document "[WMA identified Areas of Study and Training](#)" for more information on training requirements. We highly recommend that the 20 hours include:
 - Minimum 2.0 hours in ethics,
 - Minimum 2.0 hours in diversity/cultural awareness.
4. At least 20 hours of documented mediation experience within the two-year renewal cycle.
5. WMA member in good standing (WMA member dues must be current)

The WMA is no longer accepting original or renewing applications for Areas of Specialization designation. Your certification will be renewed under "General" classification only. We feel that this will allow mediators to more accurately and more flexibly represent their practice to the community.
